Up to \$15,000 for litigation costs;

Up to \$10,000 for a service award to the proposed class representative(s);

Estimated \$10,000 for settlement administration costs;

Payment of \$3,750 (75% of \$5,000 PAGA penalty) to the LWDA; and

C. Plaintiff and the Class' releases of Defendants from claims described herein.
