1 **AMENDED JUDGMENT**

2 The Judgment entered on February 15, 2024, is hereby amended as follows:


3 As confirmed by the Settlement Administrator, on September 13, 2024, the Settlement
4 Administrator issued 1,160 checks from the QSF representing the class and PAGA settlement payments.
5 All checks mailed were valid for 180 calendar days from the date of disbursement, or until March 12,
6 2025 ("Check Cashing Deadline").

7 Following the Check Cashing Deadline, 212 checks remained uncashed, totaling \$45,153.25.
8 The unclaimed settlement residuals, totaling \$45,153.25, are to be tendered by the Settlement
9 Administrator to the settlement's cy pres recipient, California Rural Legal Assistance, Inc. The
10 Settlement Administrator is also directed to distribute the withheld portion of the fee award to Class
11 Counsel.
