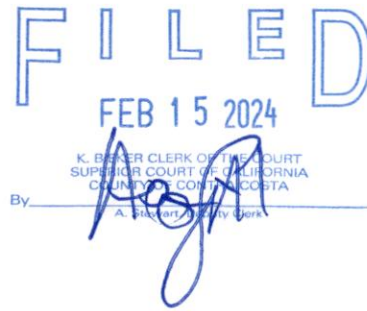

1 **JUDGMENT**


2 Judgment in this matter is entered in accordance with the Order Granting Motion for Final  
3 Approval of Class Action and PAGA Settlement and Motion for Attorneys' Fees, Costs and Expenses,  
4 and a Class Representative Enhancement Payment.

5 Five percent of Class Counsel's fee award, or \$15,833.35, is to be kept in an interest-bearing  
6 account established by the Settlement Administrator until the completion of the distribution process and  
7 Court approval of a final accounting. Plaintiff shall file and serve a report/declaration summarizing all  
8 distributions made pursuant to the approved Settlement on or before June 20, 2025. The Court sets an  
9 OSC re Compliance with the terms of the Settlement for July 17, 2025 at 9:00 a.m.

10 Without affecting the finality of the Judgment, the Court shall retain exclusive and continuing  
11 jurisdiction over the above-captioned action and the parties, including all Participating Class Members  
12 and PAGA Members, for purposes of enforcing the terms of the Judgment entered herein. This  
13 document shall constitute a judgment (and separate document constituting said judgment) for purposes  
14 of California Rules of Court, Rule 3.769(h).
