Plaintiff's unopposed Motion for Preliminary Approval of a Class Action Settlement came before this Court, on October 26, 2018, the Honorable Roger Ross presiding. The Court having considered the papers submitted in support of the application of the parties, HEREBY ORDERS THE FOLLOWING:

1. The Court grants preliminary approval of the Settlement and the Settlement Class based upon the terms set forth in the Joint Stipulation of Settlement and Release of Class Action ("Settlement Agreement") attached as Exhibit A to the Declaration of Jonathan Melmed on in support of Plaintiff's Notice of Motion and Memorandum in Support of Motion for Preliminary Approval of Class Action Settlement. All terms used herein shall have the same meaning as defined in the Settlement Agreement. The settlement set forth in the Settlement Agreement appears to be fair, adequate and reasonable to the Class.

- 2. The Settlement falls within the range of reasonableness and appears to be presumptively valid, subject only to any objections that may be raised at the final fairness hearing and final approval by this Court.
- 3. A final fairness hearing on the question of whether the proposed Settlement, attorneys' fees and costs to Class Counsel, and the Class Representative's Enhancement Award should be finally approved as fair, reasonable and adequate as to the members of the Class is scheduled in Department 11B on the date and time set forth in the implementation schedule in Paragraph 10 below.
- 4. This Court approves, as to form and content, the Notice of Proposed Class Action Settlement and Hearing Date for Court Approval ("Class Notice"), in substantially the form attached to the Settlement Agreement as **Exhibit 1**, and the Share Form in substantially the form attached thereto as **Exhibit 2**. The Court approves the procedure for Class Members to participate in, to opt out of, and to object to, the Settlement as set forth in the Settlement Agreement.
- 5. The Court directs the mailing of the Class Notice, and the Share Form by first class mail to the Class Members in accordance with the Implementation Schedule set forth below. The Court finds the dates selected for the mailing and distribution of the Notice and the Share Form, as set forth in the Implementation Schedule, meet the requirements of due process and provide the best notice practicable under the circumstances and shall constitute due and sufficient notice to all persons entitled thereto.
- 6. It is ordered that the Settlement Class is preliminarily certified for settlement purposes only.
- 7. The Court confirms Plaintiff Jackie Thompson as Class Representative, and Jonathan Melmed of Melmed Law Group P.C. as Class Counsel.
 - 8. The Court appoints CPT Group, Inc. as the Settlement Administrator.
