1 Based upon the Joint Stipulation for a [Proposed] *Nunc Pro Tunc* Order Amending Order
2 Granting Final Approval of Class Action Settlement and Final Judgment submitted by the Parties, and
3 for good cause shown:

4 1. The Court's Order Granting Final Approval of Class Action Settlement (the "FA Order") is
5 hereby amended, *nunc pro tunc*, to read as follows at page 5, lines 2-4:

6 "The \$7,500 requested by Plaintiff for her Class Representative Service Payment is reduced to
7 \$5,000 with the remaining \$2,500 being retained in the Net Settlement Amount for distribution
8 to Participating Class Members. The Court grants final approval of, and orders the Class
9 Representative Service Payment to be made, in accordance with the Agreement."

10 2. The Final Judgment is hereby amended, *nunc pro tunc*, to read as follows at page 2, lines 16-
11 18:

12 "Defendant shall fund the settlement in the escalated gross amount of \$185,649.13 (\$155,000 +
13 \$30,649.13 escalator) in accordance with the terms of the Settlement Agreement and the
14 allocations set forth in the Final Approval Order."
