The Parties reached a settlement subject to Court approval as represented in the Joint Stipulation and Settlement of Class Action and Private Attorneys General Act Claims (the "Stipulation" and "Settlement Agreement") that was filed previously with this Court. On May 12, 2022 this Court conducted a Final Settlement Fairness Hearing pursuant to Rule 3.769 of the California Rules of Court and this Court's previous Order Granting Plaintiff's Motion for Preliminary Approval of Class Action Settlement (the "Preliminary Approval Order") entered herein on January 14, 2022. Due and adequate notice having been given to the Settlement Class as required in said Preliminary Approval Order, and the Court having considered all papers filed and proceedings had herein and otherwise being fully informed in the matter, and good cause appearing therefore:

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED:

- 1. The Motion for Final Approval of Settlement and Attorney's Fees and Costs filed by Plaintiff Jesus Mayoral is granted;
 - 2. The Court certifies the class for purposes of settlement;
- 3. The Court finds that the settlement is fair, adequate, and reasonable and finds that the Gross Fund Value of \$150,000 and the means of distributing the Net Fund Value to Participating Class Members are fair, reasonable and adequate. The Claims Administrator will distribute the Net Fund Value to participating class members in accordance to the instruction and timeline set forth in the settlement;
- 4. The Court hereby confirms Bruce Kokozian, Esq. of Kokozian Law Firm, APC as Class counsel. The Court hereby awards attorneys' fees to Class Counsel in the amount of \$49,500 and costs of \$7,581.40;
 - 5. Class Representative Jesus Mayoral is awarded an enhancement payment of \$5,000;
- 6. The Claims Administrator, CPT Group, Inc. is awarded costs in the amount of \$12,000 for administration of the settlement;
- 7. Payment of \$3,375 for PAGA payment (75% of \$4,500 PAGA penalty) payable to the LWDA is approved;
 - 8. Non- Appearance Case Review re submission of Final Report is scheduled for EF at
