19 On April 19, 2019, the Court heard argument concerning the motion for final
20 approval of the class action and PAGA (“Private Attorney General Act) settlement herein,
21 pursuant to California Rule of Court, Rule 3.769 and this Court’s earlier Order Granting
22 Preliminary Approval. The Court having considered the arguments of counsel, the
23 pleadings and declarations filed in connection with the motion, orders as follows:

- 24 1. The Court certifies the Class for purposes of settlement;
25 2. The Court finds that the settlement is fair, adequate and reasonable;
26 3. Knapp, Petersen & Clarke, as Class Counsel, are awarded \$190,000 in
27 attorneys’ fees and \$25,000 in costs;
28 4. Class representatives Mariaelena Sprunk (“Sprunk”) and Sebrina Bow

1 (“Bow”) are awarded enhancement payments of \$11,750 (\$9,250 to Sprunk and \$2,500 to
2 Bow);

3 5. The claims administrator, CPT Group, Inc. is awarded \$11,750 in costs;

4 6. Payment of \$26,250 as a PAGA payment (75% of a \$35,000 PAGA penalty)
5 payable to the LWDA (“Labor and Workforce Development Agency”) is approved; and

6 7. Payment of \$5,000 from 25% of the \$35,000 PAGA penalty payable to
7 Sprunk and Bow (\$2,500 each) is approved.

8 **IT IS SO ORDERED.**


