I, JOSE MARIA D. PATINO, JR., declare as follows:

- 1. I am a Senior Attorney of Setareh Law Group ("SLG"), licensed and admitted to practice before the courts of the State of California, and am an attorney-of-record in this action for Plaintiff Alyssa Burnthorne-Martinez and the classes that she and the other Plaintiffs, Rose Provencio, Jessica Duran, Lacey Hernandez, and Brenda Morales (collectively, "Plaintiffs") represent in this Coordinated Action against Defendant Sephora USA, Inc. ("Defendant" or "Sephora") (Defendant and Plaintiffs, collectively, the "Parties").
- 2. I have personal knowledge of the facts in this Declaration and, if called as a witness, I could and would testify competently thereto. I make this Declaration in support of Plaintiffs' Motion for Final Approval of Class Action Settlement (the "Motion") and, more specifically, to address a specific issue in connection with the Court in its April 5, 2022 tentative ruling on the Motion (the "Tentative Ruling").
- 3. I am the attorney at SLG currently assigned to the settlement approval process in this matter. My involvement with this long-running Coordinated Action began with the supplemental briefing in support of preliminary approval that was submitted in November 2021.

Erroneous Litigation Costs Items Submitted in Support of Final Approval Motion

- 4. An expense summary incorrectly listing SLG's expenses in this matter was inadvertently submitted in support of the Motion for Final Approval. Specifically, SLG's expense summary erroneously included costs from a separate class action that Ms. Burnthorne-Martinez had prosecuted against Defendant for violations of the Fair Credit Reporting Act ("FCRA") (the "Sephora FCRA Action") concurrently with this matter. These extra cost entries can be identified by the "Sephora USA FCRA" label in the "Account" column on the expense summary. (*See* Declaration of Shaun Setareh in Support of Coordinated Plaintiffs' Motion for Final Approval of Class Action Settlement, Ex. 1.) Correct entries are labeled "Sephora USA" only. (*Id.*)
- 5. I originally submitted a correct total of \$109,143.47 in litigation costs sought for approval of in SLG's supplemental papers in support of Plaintiffs' Motion for Preliminary Approval. (See Declaration of Jose Maria D. Patino, Jr. in Support of Coordinated Plaintiffs' Motion for

Preliminary Approval of Class Action Settlement ("Patino MPA Declaration"), ¶ 12.) I submitted this total based upon prior account queries that were run prior to my involvement in this Action.

- 6. When preparing and drafting the declaration from SLG in support of final approval, the cost item query again had to be run. However, instead of the total amount, the purpose of the query was to obtain an enumerated listing of the individual cost items in this case. Unbeknownst to me, by requesting a report of all cost items from the "Sephora" case with Ms. Burnthorne-Martinez, I had obtained the cost items not only from the present action, but also from the Sephora FCRA Action, which had been a separate but concurrent action. Since this matter and the Sephora FCRA Action overlapped in time, and since, due to my only recent involvement in this Action, I did not know that there had been a separate class action between Ms. Burnthorne-Martinez and Sephora, I had no reason to believe at the time that any of the cost items listed were from a different case.
- 7. After the Tentative Ruling came down, and the submitted SLG cost items were reviewed in preparation to draft a response, it was noticed that several of the items were categorized as "Sephora USA FCRA" while a majority of the items were categorized as "Sephora USA" in the "Account" column. It was brought to my attention that the Sephora FCRA Action had existed, that it was a concurrent class action between Ms. Burnthorne-Martinez and Sephora for alleged FCRA violations, and that it settled in 2018. With this newly learned information, and after comparing the cost items categorized as "Sephora USA FCRA," I realized and confirmed that these cost items were made in the Sephora FCRA Action and not this Action.
- 8. The cost items belonging to the Sephora FCRA Action have since been removed from SLG's expense summary. (See Supplemental Declaration of Shaun Setareh in Support of Coordinated Plaintiffs' Motion for Final Approval of Class Action Settlement, Ex. B.) A true and correct copy of a spreadsheet enumerating the costs from the Sephora FCRA Action—now removed from SLG's expense summary—is attached hereto as **Exhibit 1**. For the Court's ease of reference, I have highlighted the items in Exhibit 1 that were identified by the Tentative Ruling for further explanation by SLG, but which are actually attributable to the Sephora FCRA Action, and which have been accordingly removed.

No Relationship with or Interest in the Designated Cy Pres Recipient 9. I do not have any relationship with or interest in Legal Aid at Work. 10. On May 2, 2022, at the direction of Shaun Setareh, I sent out an email to the attorneys and staff of SLG inquiring whether any of them had any relationship with or interest, financial or otherwise, in Legal Aid at Work, the cy pres recipient designated in the First Amended Class Action Settlement and Agreement (the "Settlement"). To date, no attorney or staff member of SLG has reported any relationship with or interest in Legal Aid at Work.
