- 1. Judgment in this matter is entered in accordance with the Court's Order Granting Final Approval of Class Action Settlement and the parties' Joint Stipulation for Class Action Settlement ("Settlement Agreement"). - 2. Consistent with the definitions provided in the Settlement Agreement, the settlement class consists of: All current and former non-exempt hourly employees who worked at Southland Sod's facilities in the state of California, including temporary non-exempt hourly employees placed to work at Southland Sod's facilities in California by Del Sol at any time between May 24, 2013 through April 23, 2018.
- 3. Without affecting the finality of the Judgment, the Court shall retain exclusive and continuing jurisdiction over the above-captioned action and the parties, including all Class Members, for purposes of enforcing the terms of the Judgment entered herein.
- 4. This document shall constitute a Judgment for purposes of California Rules of Court, Rule 3.769(h).
