1 **JUDGMENT**

2 Pursuant to the Order Granting Final Approval of Class Action Settlement entered on
3 October 10, 2018, it is hereby **ORDERED, ADJUDGED AND DECREED** as follows:
4

5 1. Judgment in this matter is entered in accordance with the Court’s Order Granting
6 Final Approval of Class Action Settlement and the parties’ Joint Stipulation for Class Action
7 Settlement (“Settlement Agreement”). Unless otherwise provided herein, all capitalized terms
8 used herein shall have the same meaning as defined in the Settlement Agreement.
9

10 2. As provided by the Order Granting Final Approval of Class Action Settlement, all
11 Class Members who did not timely opt-out from the settlement are barred from pursuing, or
12 seeking to reopen, any of the released claims, as defined in the Settlement Agreement. Consistent
13 with the definitions provided in the Settlement Agreement, the settlement class consists of: All
14 current and former non-exempt hourly employees who worked at Southland Sod’s facilities in the
15 state of California, including temporary non-exempt hourly employees placed to work at
16 Southland Sod’s facilities in California by Del Sol at any time between May 24, 2013 through
17 April 23, 2018.
18

19 3. Without affecting the finality of the Judgment, the Court shall retain exclusive and
20 continuing jurisdiction over the above-captioned action and the parties, including all Class
21 Members, for purposes of enforcing the terms of the Judgment entered herein.
22

23 4. This document shall constitute a Judgment for purposes of California Rules of
24 Court, Rule 3.769(h).
