JUDGMENT

Pursuant to the Order Granting Final Approval of Class Action Settlement entered on August 30, 2021, it is hereby **ORDERED, ADJUDGED AND DECREED** as follows:

1. Judgment in this matter is entered in accordance with the Court's Order Granting Final Approval of Class Action Settlement and the parties' Joint Stipulation and Agreement for Class Action Settlement ("Settlement Agreement"). Unless otherwise provided herein, all capitalized terms used herein shall have the same meaning as defined in the Settlement Agreement.

2. As provided by the Order Granting Final Approval of Class Action Settlement, all Class Members who did not timely opt-out from the settlement are barred from pursuing, or seeking to reopen, any of the released claims, as defined in the Settlement Agreement. Consistent with the definitions provided in the Settlement Agreement, the settlement class consists of: All current and former non-exempt hourly employees of M. Block within California, including temporary non-exempt hourly employees placed to work at M. Block's California location at any time during the period of January 27, 2013 through April 27, 2019.

3. Without affecting the finality of the Judgment, the Court shall retain exclusive and continuing jurisdiction over the above-captioned action and the parties, including all Class Members, for purposes of enforcing the terms of the Judgment entered herein.

4. This document shall constitute a Judgment for purposes of California Rules of Court, Rule 3.769(h).


