I, Donday Orr, declare:

I make this statement based on my personal knowledge. I am prepared and
 competent to testify to the matters set forth in this declaration.

2. I have been employed as an operator by the Los Angeles County Metropolitan Transportation Authority ("Defendant") from February 2007 to the present.

3. I understood when I became a named plaintiff in this case that there was some
personal risk to me as a named plaintiff, because there have been other wage-and-hour actions
in which a defendant had prevailed and the named plaintiffs had been held liable, jointly and
severally, for the defendant's attorneys' fees. I also understood that some plaintiffs suing their
employers have faced retaliation from their employers, up to and including termination of
their employment, even though there are laws prohibiting retaliation. Nevertheless, I believed
that prosecution of the lawsuit was in the interests of justice.

I have spent a lot of time working with my attorneys on this case. Throughout
the time that I have spent in connection with this case, I have understood that I act as a
representative of other, unnamed class members, and that as such a representative, I owe a
duty of good faith to the unnamed class members, and that I will not act just in my own selfinterest. My main concern is that all class members be treated fairly.

5. I have taken an active role in this litigation by conferring with my counsel and 18 assisting in gathering information and documents for the prosecution of the lawsuit. I have 19 conferred with my counsel numerous times during the course of the lawsuit. During those 20 discussions, my counsel advised me about this lawsuit and class action lawsuits generally, and 21 I provided relevant information. I also reported to my counsel information that I learned from 22 other operators regarding their work experiences. I have spent time explaining the relevent 23 policies and practices, locating witnesses, reviewing documents, and providing information to 24 assist with the prosecution of the lawsuit and in the settlement negotiations. I prepared for my 25 deposition and was deposed. I have been actively involved in following what has been 26 occurring in the case and I have provided information and documents in order to assist in the 27 lawsuit on several occasions. All told, I estimate that I have devoted at least 80 hours of my 28 2

6. I have been advised by my counsel throughout the settlement discussions that
have occurred in this case and that resulted in the settlement. I have reviewed the settlement
agreement filed October 1, 2019, as modified by the Stipulation and Order Regarding
Settlement filed March 13, 2020, and I believe that the terms are fair, adequate, and
reasonable to the settlement class.

7. I believe that I am similarly situated with the members of the settlement class 7 in that I, like other class members, was employed by Defendant as an operator during the class 8 9 period, and experienced the same policies and practices at issue in this lawsuit. In connection with this lawsuit, I feel that I am a good representative of the other class members. My interest 10 in assisting with the prosecution (and settlement) of the lawsuit is to secure a fair and 11 reasonable resolution for all of the members of the class with respect to violations of the labor 12 laws, and to ensure that all class members are treated fairly. I have not been promised any 13 special monetary reward or treatment for doing so. I have no interest adverse to the members 14 of the class as a whole. I believe that my individual claims are typical of the claims of the 15 members of the class as a whole 16 8.
