1 The Motion for Preliminary Approval of a Class Action Settlement came before this
2 Court on Sept 8, 2020. The Court having considered the papers submitted in
3 support of the application of the Parties, HEREBY ORDERS THE FOLLOWING:

4 1. The Court grants preliminary approval of the Settlement and the Settlement Class.
5 based upon the terms set forth in the Stipulation Regarding Class Action Settlement and
6 Distribution of Settlement Amount to Settlement Class ("Stipulation"). All terms used herein
7 shall have the same meaning as defined in the Stipulation. The Settlement appears to be fair,
8 adequate and reasonable to the Class.

9 2. The settlement falls within the range of reasonableness and appears to be
10 presumptively valid, subject only to any objections that may be raised at the final fairness
11 hearing and final approval by this Court.

12 3. A Final Fairness Hearing on the question of whether the proposed settlement,
13 attorneys' fees and costs to Class Counsel, and the Class Representatives' Enhancement Awards
14 should be finally approved as fair, reasonable and adequate as to the members of the Class is
15 scheduled in Department 1 on the date and time set forth in the implementation schedule in
16 Paragraph 9 below.

17 4. This Court approves, as to form and content, the Notice of Class Action Settlement,
18 the Hearing Date for Court Approval, and Settlement Procedures in substantially the form
19 attached as Exhibit "B" to the Declaration of Marcus J. Bradley and also approves the procedure
20 for Class Members to participate in, opt out of, and object to the settlement as set forth in the
21 Stipulation and Notice of Class Action Settlement.

22 5. The Court directs the mailing of the Notice in accordance with the implementation
23 schedule set forth in the Stipulation and finds the dates selected for the mailing and distribution
24 of the mailing of the Notice as set forth therein meet the requirements of due process and
25 provide the best notice practicable under the circumstances and shall constitute due and
26 sufficient notice to all persons entitled thereto.

27 6. It is ordered that the Settlement Class is preliminarily certified for settlement
28 purposes only.

1 7. The court approves Demarie Louis and Charday Tolley as Class Representatives, and
2 Bradley/Grombacher LLP and The Law Offices of Sahag Majarian II as Class Counsel for the
3 Settlement Class.


4 8. The Court confirms CPT Group as the Settlement Administrator.
