THIS STIPULATION and ORDER is hereby entered into by and between Plaintiff Azizi Baranauskas ("Plaintiff"), on behalf of herself and all others similarly situated to her, on the one hand, and Defendants Healthcare Management Services, LLC; MEK Arden, LLC; MEK Associates, LLC; MEK Escondido, LLC; MEK Kennedy, LLC; MEK L.V. Property, LLC; MEK Leisure Glen, LLC; MEK Long Beach, LLC; MEK Norwood Pines, LLC; MEK Office Property, LLC; MEK Palomar Property, LLC; MEK R.O. Property, LLC; MEK Sacramento LLC; Palomar Heights Care Center, LLC; and B.V. General, Inc. ("Defendants"), on the other hand, and through their respective counsel of record. Plaintiff and Defendants will be collectively referred to as the "Parties."

WHEREAS, on November 1, 2019, the Court granted preliminary approval of the class action settlement entered into by the Parties and ordered a schedule of dates for the class notice and final approval of the settlement;
