DECLARATION OF STANLEY D. SALTZMAN

I, STANLEY D. SALTZMAN, declare as follows:

- 1. I am an individual over the age of 18. I am a California bar-admitted attorney and am a partner in the firm of Marlin & Saltzman, LLP. I am also admitted to practice before the various district courts within California, including the Central District where this matter is venued. I am one of the attorneys of record for Plaintiffs in this action. I have personal knowledge of the facts set forth below and if called to testify I could and would do so competently.
- 2. This Declaration is made in support of Plaintiffs' Motion for Final Approval of Class Action Settlement.
- 3. On December 19, 2018, my law firm provided notice of the proposed settlement to the California Department of Labor and Workforce Development ("LWDA") pursuant to Labor Code § 2699(l). As of the date of this filing, I have received no response from the LWDA.
- 4. My firm and I have been involved in dozens of settlements in wage and hour cases since CAFA was enacted in 2005, and no State or Federal official has *ever* responded to a CAFA notice in any of our cases, be they large or small, including settlements in excess of one hundred million dollars. I have no reason to believe that this non-reversionary, non-claims made Settlement, affording considerable relief to the decertified class, would be any different.
