— NOTICE OF SETTLEMENT —

A court authorized this notice. This is not a solicitation from a lawyer. This is not a lawsuit against you, and you are not being sued. However, your legal rights are affected whether you act or not. Please read this notice carefully.

TO: All individuals who, at any time between April 3, 2020, and November 30, 2023, were employed by Northwest Fire Systems LLC in the State of Washington and worked in a position that required driving company-owned vehicles and were allowed or required to park company-owned vehicles at their homes.

- A former employee brought claims against Northwest Fire Systems LLC ("The Company") alleging that the Company failed to pay for all hours worked, including all time driving company vehicles, failed to pay proper prevailing wage, and failed to pay proper overtime. The Company strongly denies these claims. The parties have reached a proposed Class Action Settlement.
- The Company strongly denies any fault, wrongdoing, or liability. If the Parties had not reached a Settlement, the Company would have continued to vigorously defend against Plaintiff's claims, including seeking a denial of class certification and a full defense verdict at trial. The Company agreed to this Settlement to avoid the risk, burden, and expense of further litigation, and as a means of making its employees whole for even any arguable claims relating to the lawsuit.
- The Class Action Settlement includes a total maximum settlement payment by the Company of Gross Settlement Amount Dollars (\$550,000).
- To qualify for a share of this payment: (A) you must have been employed by the Company and worked in a position that required driving a company-owned vehicle and were allowed or required to park said vehicles at your homes in the State of Washington between April 3, 2020, and November 30, 2023; and (B) you must not exclude yourself from the Class Action Settlement in the manner outlined below.
- If you were employed by Northwest Fire Systems LLC and worked in a position that required driving a company-owned vehicle and were allowed or required to park the company-owned vehicle at your home in the State of Washington at any time between April 3, 2020 and November 30, 2023, you do not have to do anything to be eligible to receive a share of the settlement payment.

• The Court in charge of this Case still has to decide whether to finally approve the Settlement. If the Court approves the Settlement, payments will be made after any appeals are resolved. Please be patient.

1. Why did I get this Notice?

The Company's records show that you were employed by the Company and worked in a position that required driving a company-owned vehicle and were allowed or required to park said vehicles at your home in the State of Washington between April 3, 2020 and November 30, 2023. The Court has allowed this Notice to be sent to you to inform you about a proposed settlement of a class action lawsuit, and about your options, before the Court decides whether to finally approve the Settlement. If the Court approves the Settlement, and after any appeals are resolved, payments will be made to Settlement Class Members who do not affirmatively request to be excluded from the Settlement.

This Notice explains the Case, the Class Action Settlement, your legal rights, what benefits are available, who is eligible for them, and how to get them.

2. What is the Case about?

The Plaintiff, former employee Brian F. Rodrigues, claims that the Company violated Washington State wage and hour laws by failing to pay for all hours worked including, but not limited to all drive and travel time and other hours worked, by failing to pay proper prevailing wage, and by failing to pay proper overtime in conformity with the requirements of Washington law. The Company has denied the Plaintiff's claims.

The Honorable Gretchen Leanderson, of the Superior Court for the State of Washington in and for Pierce County, is overseeing this Class Action. The lawsuit is known as *Brian F. Rodrigues v. Northwest Fire Systems LLC*, Pierce County Superior Court Civil Case No. 23-2-05879-3 (the "Case").

3. What is a class action and who is involved?

In a class action lawsuit, one or more people called a "Class Representative" sues on behalf of other people whom they believe have similar claims. The people together are a "Class" or "Class Members." The employee(s) who sued, and who represent(s) the Class, are called the Plaintiff(s).

The person the Plaintiff(s) sue(s) (in this case the Company) is called the Defendant. In a class action, one court resolves the issues for everyone in the Class—except for those people who choose to exclude themselves from the Class.

4. Why is there a Settlement?

The Court did not decide in favor of the Plaintiff or the Company. Instead, both sides agreed to a Settlement. This allows the parties to avoid the cost of a trial, and the people affected will be entitled to compensation. The Class Representative and his attorneys think the Settlement is best for everyone in the Class.

5. How do I know whether I am part of the Settlement?

As part of the Settlement of the Case, the Pierce County Superior Court has decided that everyone who fits the following description is a Settlement Class Member:

All individuals who were employed by Northwest Fire Systems LLC in Washington state and worked in a position that required driving a company-owned vehicle and required or allowed the vehicle to be parked at their homes at any time from April 3, 2020 through November 30, 2023.

As part of the Settlement of the Case, the Pierce County Superior Court has decided that everyone who fits the following description is a Settlement Subclass Member:

All Class Members who were not subject to the collective bargaining agreement between the National Fire Sprinkler Association, Inc. and Sprinkler Fitters and Apprentices Local Union No.

699 Seattle, Washington of the United Association of Journeymen and Apprentices of the Plumbing and Pipe Fitting Industry of the United States and Canada.

If it is approved, the Settlement will cover all Settlement Class Members who have not timely and affirmatively excluded themselves from the Case. To be a part of and receive any money pursuant to the Settlement, Settlement Class Members need do nothing (other than refrain from affirmatively opting out of the Settlement).

6. What claims are covered by the Settlement?

The Settlement will resolve all of the claims Settlement Class and Subclass Members could have brought against the Company regarding an alleged failure to pay for all hours worked including, but not limited to driving and travel time, failure to pay proper prevailing wages, and failure to pay proper overtime required by Washington law (collectively, the "Released Claims").

The Released Class Claims include all claims, whether known or unknown, that were brought or that could have been brought based on any facts alleged in the Case with respect to any failure to pay for all hours worked, failure to properly pay statutory overtime, and failure to provide meal periods and/or rest breaks. The Released Claims specifically include, but are not limited to, any claims arising out of or relating to: (1) any claims for unpaid drive and travel time or other hours worked; (2) any claims for underpaid prevailing wage; (3) any claims for improperly paid overtime; and (4) any attendant claims for unpaid wages, overtime, premium payments, exemplary damages, interest, and attorneys' fees and costs arising out of or relating to any of the foregoing.

The Release Claims by Subclass members also include any claims arising out of or relating to any alleged missed, interrupted, shortened, untimely, unpaid, and/or noncompliant rest breaks and/or meal period.

7. What are the basic terms of the Settlement?

Subject to Court approval, the essential terms of the Settlement are as follows:

The Company will pay a total of \$550,000 as part of the Settlement, apportioned as follows:

- Class Fund: The Company will pay approximately \$311,500, which will be available for the payment of Settlement Awards to Settlement Class Members who do not timely opt out of this Settlement.
- Employer-side Payroll Taxes: Employer-side Payroll Taxes will be paid out of the settlement fund.
- Attorneys' Fees and Costs Award: The Company will pay up to \$165,000 to Plaintiff's attorney for the attorneys' fees award and up to \$8,000 for actual litigation costs they have incurred and will incur through final judgment in representing Plaintiff and the Settlement Class. This amount will be paid out of the settlement fund.
- **Service Award**: The Company will pay up to \$7,500 to Plaintiff and Class Representative Brian F. Rodrigues as a service award in recognition of his efforts in prosecuting the Case. This amount will be paid out of the settlement fund.
- Full Release Award: The Company will pay up to \$40,000 to Plaintiff Brian F. Rodrigues in exchange for a release of any and all, known or unknown individual claims arising out of his application for employment, employment, and/or cessation of employment with the Company. This amount will be paid out of the settlement fund.
- Settlement Administration Expenses Award: The Company will pay up to \$12,000 to the Settlement Administrator for the processing of the Settlement, including the expenses of providing notice of the Settlement, handling the claims administration process, processing payments to Settlement Class Members, and handling tax reporting requirements. This amount will be paid out of the settlement fund.

Monetary Relief: The amount available to the Settlement Class is intended to compensate Settlement Class Members for the wages and other compensation they allegedly lost and damages they are allegedly owed as a result of the practices alleged in the Case.

"Weighted Hours Worked": for purposes of equitably allocating the net settlement amount among Settlement Class and Subclass Members, means the total number of hours worked by Settlement Class Members who are not Settlement Subclass Members and the total number of hours worked by Settlement Subclass Members times 1.35.

Distribution of Settlement Fund: Each Settlement Class Member who does <u>not</u> submit a valid and timely request for exclusion will automatically receive a settlement payment. Each Settlement Class Member who does not request exclusion shall receive a minimum settlement payment of \$200. The remaining amount from the class fund will be allocated to individual Settlement Class Members on a pro rata basis, based on weighted hours worked during the Class Period, with the amounts being calculated by dividing each Settlement Class Member's total weighted hours worked during the Class Period by the total aggregate weighted hours worked by all Settlement Class Members during the Class Period and then multiplying the resulting ratio by the portion of the class fund allocated to these payments. Checks will be mailed to Settlement Class Members by the Settlement Administrator. If any checks have not been negotiated within one hundred twenty (120) days after distribution, the funds from those checks will be sent in the corresponding Settlement Class Member's name to the Unclaimed Property Fund for the State of Washington pursuant to the Unclaimed Property Act (RCW 63.29 et seq). The Company will not receive funds from any uncashed checks.

Tax Treatment of Settlement Awards: Fifty Percent (50%) of each Settlement Class Member's settlement award will be treated as wages and subject to normal tax withholding and shall be reported to the taxing authorities and the Settlement Class Member on an IRS Form W-2. Fifty Percent (50%) of each Settlement Class Member's settlement award will be treated as non-wages (a combination of liquidated and exemplary damages, enhancements, and prejudgment interest) on which there will be no tax withholding and for which an IRS Form 1099-MISC (marked "Other Income") shall be issued to the taxing authorities and the Settlement Class Member. In addition to contributing to the Settlement Fund described above, the Company is also paying all required employer-paid taxes incurred as part of the Settlement. The Company's payment of these employer-paid taxes will not decrease the funds available to Settlement Class Members.

Release of Claims: Upon final approval by the Court, the Settlement Class and each Settlement Class Member who has not submitted a valid and timely written request to be excluded from the Settlement will irrevocably release all of the Released Claims against the Company relating to the period from April 3, 2020 through November 30, 2023.

This Release specifically includes any claims arising out of or relating to any unpaid travel time, statutory overtime, and underpaid prevailing wages and any attendant claims for unpaid wages, overtime payments, premium payments, interest, exemplary damages, and attorneys' fees and costs arising out of or relating to any of the foregoing. The release by Settlement Subclass Members includes any alleged missed, interrupted, shortened, untimely, unpaid, and/or non-compliant rest breaks and/or meal periods.

This Release requires you to waive and precludes you from bringing any Released Claims against the named Defendant in the case, Northwest Fire Systems LLC, as well as its past, current, or future predecessors, successors, and assigns, together with each of their respective parent companies, subsidiaries, related or affiliated companies, members, shareholders, owners, officers, directors, employees, agents, attorneys, and insurers, along with any other individual or entity who could be jointly or severally liable for any of the Released Claims.

Dismissal of Action: Upon final approval, the Court will enter a judgment of dismissal of the Case with prejudice but shall retain jurisdiction to enforce the terms of the settlement.

8. How can I get a payment?

To get payment, you need to do nothing. As long as you do <u>not</u> submit a written request to be excluded from the Settlement, you will be a Settlement Class Member and will be entitled to payment.

9. When would I get my payment?

The Court will hold a hearing on April 12, 2024 at 9:00 a.m. to decide whether to finally approve the settlement. If the Pierce County Superior Court approves the settlement, the parties will then have to wait to see whether there is an appeal. This will take at least thirty (30) days and, if there is an appeal, can take up to a year or more to resolve. In the event of an

appeal, information regarding the appeal's progress will be made available at: www.cptgroupcaseinfo.com/northwestfiresettlement. If there is no appeal, we expect payments will go out within approximately sixty (60) days of the Court's final approval of the Settlement. Please be patient.

10. Do I have a lawyer in this case?

The Court has decided that James B. Pizl and the lawyers from the law firm of Entente Law PLLC are qualified to represent you and all Settlement Class Members. These lawyers are called "Class Counsel." You will not be charged for these lawyers. If you want to be represented by our own lawyer, you may hire one at your own expense.

11. How will the lawyers be paid?

As indicated above, Class Counsel will seek payment of their attorneys' fees in the amount of \$165,000 and their litigation costs in the amount of up to \$8,000, each of which must be approved by the Court as part of the final approval of this Settlement. Class Counsel has been working on this case since approximately March 2023 and has not received any fees or reimbursements for the costs of the lawsuit.

12. How do I exclude myself from the Settlement?

If you fit the definition of a Settlement Class Member and want to exclude yourself from the Settlement, you <u>must</u> request exclusion in writing. You may be excluded as a member of the class by submitting a written request stating, "I request that I be excluded from the Class in the case of Brian F. Rodrigues v. Northwest Fire Systems LLC." The request must include your name, address, and signature. You <u>must</u> mail a copy of the letter to the Settlement Administrator at the following at address **postmarked no later than March 7, 2024:**

If you exclude yourself from the Settlement (i.e., opt out), you will not receive any payment from the Settlement. You will also not be entitled to object to the Settlement. If you exclude yourself, you will not be bound by the terms of the Settlement, including the Release described in Sections 6 and 7, above. This means you will retain the right at your own expense to pursue (or not pursue) any claims you may have against The Company.

13. If I don't like the Settlement, how do I tell the Court?

If you are a Settlement Class Member, have <u>not</u> excluded yourself from the Settlement, and do not like the Settlement or the fee request, you can object. You <u>must</u> do so in writing, and you <u>must</u> state the reasons why you think the Court should not approve the Settlement. If you object, be sure to include your name, address, and telephone number, the name of the Case (Brian F. Rodrigues v. Northwest Fire Systems LLC, Pierce County Superior Court Civil Case No. 23-2-05879-3), the reasons you object to the Settlement, and a signature. You <u>must</u> mail a copy of the objection to the following address **postmarked no later than March 7, 2024:**

14. When and where will the Court decide to approve the Settlement?

The Court will hold a Fairness Hearing on April 12, 2024 at 9:00 a.m., before Judge Andre Penalver at Pierce County Superior Court, Department 13, 930 Tacoma Ave S, Tacoma, WA 98402. If there are objections, the Court will consider them. Judge Penalver will listen to people who have asked to speak at the hearing (*see* Section 16). After the hearing, the Court will decide whether to finally approve the Settlement, including Class Counsel's request for Attorneys' Fees and Costs, Settlement Administration Expenses, and Service Award for the named Plaintiff. We do not know how long that decision will take.

15. Do I have to come to the hearing?

No. Class Counsel will answer any questions Judge Penalver may have, but you are welcome to attend at your own expense. If you send an objection, you do not have to come to Court to talk about it. As long as you mail or deliver your written objection on time, the Court will consider it. You may also pay your own lawyer to attend, but that is not necessary.

16. May I speak at the hearing?

You may ask the Court for permission to speak at the Fairness Hearing. To do so, you <u>must</u> send a letter saying it is your "Notice of Intention to Appear in Brian F. Rodrigues v. Northwest Fire Systems LLC, Pierce County Superior Court Civil Case No. 23-2-05879-3." Be sure to include your name, address, phone number, and your signature. Your Notice of Intention to Appear <u>must</u> be **postmarked no later than March 7, 2024**, and be sent to the Court, Class Counsel, and Defense Counsel at the three addresses set forth below:

17. What happens if I do nothing at all?

If you do nothing—that is, if you do not mail or deliver a timely written request to exclude yourself from the Settlement—you will be part of the Settlement Class and will be entitled to a share of the Settlement. You will also be bound by the terms of the Settlement, including the Release described in Sections 6 and 7, above.

18. Are there more details about the Settlement?

This Notice summarizes the proposed Settlement. More details are in the Settlement Agreement.
