28	[PROPOSED] ORDER AWARDING ATTORNEYS' F	FES AND COSTS AND SERVICE AWARDS TO CLASS

The Unopposed Motion for Approval of Attorneys' Fees and Costs and of Service Awards to Class Representatives, filed by Plaintiffs Desidero Soto, Steven Stricklen, Steeve Fondrose, Lorenzo Ortega, and Jose Antonio Farias, Jr. ("Plaintiffs") in the above-captioned action, came on for hearing on October 17, 2019 at 10:00 a.m., the Honorable Vince Chhabria presiding. Defendants O.C. Communications, Inc., Comcast Corporation, and Comcast Cable Communications Management, LLC ("Defendants") did not oppose the motion.

Having reviewed the papers and documents presented, having heard the statements of counsel, having considered the matter, the Court HEREBY ORDERS as follows:

- 1. The Court has jurisdiction over the claims of the Class and Collective Members asserted in this proceeding and over all Parties to the action;
- 2. The Court FINALLY APPROVES Class Counsel's request for attorneys' fees in the amount of one-third of the Gross Settlement Amount set forth in the initial Settlement Agreement, for a total of \$2,500,000;
- 3. The Court FINALLY APPROVES Class Counsel's request for costs in the amount of \$207,361.46;
- 4. The Court FINALLY APPROVES service awards to the five Named Plaintiffs and Class and Collective Representatives in the following amounts: \$15,000 to Desidero Soto, and \$10,000 each to Steven Stricklen, Steeve Fondrose, Lorenzo Ortega, and Jose Antonio Farias, Jr. The Court finds that these awards are fair and reasonable for the service these individuals provided to the Settlement Class and Collective and the broader release they executed than the Settlement Class and Collective Members.
