
1 TO EACH PARTY AND THEIR ATTORNEY OF RECORD:

2 PLEASE TAKE NOTICE, that on October 18, 2021, at 11:00 a.m. the court heard the above-  
3 referenced matter. Neal J. Fialkow appeared for the Plaintiffs and James Carter, with Jackson-Lewis PC,  
4 appeared for the Defendants. The court ruled as follows:

- 5 (1) The Final Approval of the Class Representative Action and Settlement is granted;
- 6 (2) the Court further approves the attorney fees of \$66,666.00 and costs of \$8,933.83 to counsel  
7 for the Plaintiffs;
- 8 (3) CPT Group, Inc. as the Claims Administrator, is awarded \$5,000.00 for its settlement services  
9 and costs;
- 10 (4) The Court approves payment of \$7,500.00 to resolve the Representative PAGA claim to be  
11 allocated 75% (or \$5,625.00) to the LWDA, and 25% (or \$1,875.00) included in the Net  
12 Settlement to the settlement class members;
- 13 (5) Plaintiffs, Ruby Sua and Cynthia Jimenez are each awarded an Enhancement Fee of  
14 \$5,000.00;
- 15 (6) CPT Group, Inc., as the Administrator, is to prepare a final distribution report of settlement  
16 funds by June 10, 2022, which Class Counsel is to file with the Court;
- 17 (7) A non-appearance Case Review re: Final Report on Distribution of Settlement Funds is set for  
18 June 22, 2022, at 8:30 a.m. before the Court;
- 19 (8) Plaintiff was ordered to give notice.
