**ORDER GRANTING PRELIMINARY  
APPROVAL OF CLASS ACTION  
SETTLEMENT**

Before the Court is Plaintiffs' unopposed motion for preliminary approval of the class action settlement reached with remaining defendant Saarman Construction, Ltd. The Court has thoroughly reviewed and considered the proposed Settlement Agreement, appended as Exhibit 1 to the supporting declaration of attorney Michael Kim, the filings related to the motion for preliminary approval, and the pleadings on file in this action. Based on the Court's review, the Court finds the matter suitable for disposition without oral argument, **VACATES** the hearing presently set for April 7, 2023, at 10:00 a.m., **GRANTS** the motion, and **ORDERS** as follows:

1. All terms or phrases used in this order shall have the same meaning as in the Settlement Agreement unless otherwise specified.

1           2.     The Settlement Agreement preliminarily appears to be within the range of possible  
2 final approval as a fair, sufficient, and reasonable settlement, such that notice should be provided to  
3 the class and subclass.

4           3.     For settlement purposes only, the following settlement class and settlement subclass  
5 are conditionally certified.<sup>1</sup>

6                   *Class:* All hourly employees who worked shifts over 8.0 hours under  
7 an Alternative Workweek Schedule in their employment by Saarman  
8 Construction Ltd. in California during the period of July 20, 2014,  
9 through April 6, 2023, but who were not paid an overtime premium  
rate for time in excess of 8.0 hours for those shifts, but excluding all  
employees who executed individual settlement agreements with  
Defendant prior to January 1, 2023.

10                   *Subclass:* All hourly employees who worked for Saarman  
11 Construction Ltd. at the public works project known as Francis of  
12 Assisi, a/k/a the Mercy Housing Project from January 20, 2014,  
13 through April 6, 2023, and who were paid an hourly rate classified as  
“Laborer Group 3” while working on that project, but excluding all  
employees who executed individual settlement agreements with  
Defendant prior to January 1, 2023.

14           4.     For settlement purposes only, the proposed settlement class and subclass meet the  
15 requirements for certification under Code of Civil Procedure section 382. Specifically, for  
16 settlement purposes: (1) the class and subclass are numerous and ascertainable; (2) there are  
17 predominant common questions of law or fact; (3) Plaintiffs’ claims are typical of the claims of the  
18 members of the class and subclass; and (4) a class action is superior to other methods to efficiently  
19 adjudicate this controversy through settlement.

20           5.     For settlement purposes only, Fernando Gutierrez, David Castillo, and Marco  
21 Gonzalez are appointed as class representatives. The Court preliminary finds that Mr. Gutierrez,  
22 Mr. Castillo, and Mr. Gonzalez will adequately represent the settlement class and subclass in  
23 accordance with Code of Civil Procedure section 382 for settlement purposes.

24           6.     For settlement purposes only, Michael H. Kim., P.C. is designated as Class Counsel.  
25 The Court preliminarily finds that Class Counsel will represent the interests of the settlement class

1 and subclass fairly and adequately in accordance with Code of Civil Procedure section 382 for  
2 settlement purposes.

3 7. CPT Group, Inc. is appointed as the settlement administrator. The Court directs CPT  
4 Group, Inc. to carry out all of the duties and responsibilities as set forth in the Settlement  
5 Agreement and this order, including *inter alia* the provision of notice to and receipt of objections  
6 by members of the settlement class and subclass.

7 8. The parties' proposed form of notice is approved as to form and content subject to  
8 the following correction: *the class and subclass definitions in the notice shall be updated in*  
9 *conformity with the Court's certification finding above such that "through the present" is changed*  
10 *to "through April 6, 2023."* Counsel and the settlement administrator shall ensure that all deadlines  
11 and addresses are accurately populated in the final form and shall proofread the notice again before  
12 it is disseminated in English and Spanish.

13 9. The proposed plan for distributing notice—in both English and Spanish—and the  
14 related procedures for opt-outs, objections, and shift disputes set forth in the Settlement Agreement  
15 (§§ 34, 36–40) are approved, meet the requirements of due process, and constitute the best notice  
16 practicable under the circumstances.

17 10. A final approval hearing is set for **July 20, 2023, at 9:00 a.m.** in Department 613 of  
18 the Superior Court of California, County of San Francisco, located at 400 McAllister Street, San  
19 Francisco, California 94102. At the final approval hearing, the Court will consider whether the  
20 Settlement Agreement is fair, whether Class Counsel's application for fees and costs should be  
21 approved, whether Plaintiffs' requests for service awards should be approved, and any other matters  
22 that the Court deems appropriate.
