WHEREAS, it will take approximately 30 days for Plaintiffs, working diligently with the settlement administrator, to draft and file the Motion for Final Approval;

WHEREAS, the Parties respectfully submit that judicial economy would be best served if the currently scheduled Final Approval Hearing of October 4, 2023 is continued to December 13, 2023, or as soon thereafter as this matter may be heard.
