Judgment is hereby entered in accordance with the terms of the Court's Order Granting Final Approval of Class Action Settlement, dated January 11, 2021 (the "Final Approval Order"),

The Class is defined as: "[T]he employees identified in the Class List, attached as Exhibit 1 to the Settlement Agreement (and which will also be attached as Exhibit A to the Class Notice), who were employed by Volar, LLC d/b/a Sakesan Sushi and Bistro in San Francisco, California between April 24, 2013 and April 24, 2017, and who did not previously sign a Settlement Agreement and Release of All Claims with Volar, LLC."

No Class Members requested exclusion from the Settlement Class.

Pursuant to the awards granted in the Final Approval Order, \$107,724.32 will be paid to the

1 Class Members if all Class Members are paid the amount to which they are entitled pursuant to the
2 Final Approval Order and this Judgment.

3 Plaintiffs and the Settlement Class shall take nothing from the Released Parties except as set
4 forth in the Settlement Agreement and the Final Approval Order.

5 Pursuant to the Settlement Agreement, Code of Civil Procedure § 664.6, and California Rules
6 of Court, rule 3.769(h), the Court retains jurisdiction over the parties and the action for the purposes
7 of supervising the implementation, enforcement, construction, administration, and effectuation of the
8 Settlement.

9 Notice of entry of this Judgment shall be given to the Settlement Class by posting the Final
10 Approval Order and this Judgment on the administrator's website for a period of not less than 60 days
11 from the date this judgment is entered. It shall not be necessary to send notice of the entry of this
12 Judgment to the Settlement Class by any other means.

13 This document shall constitute a judgment pursuant to and California Rules of Court, rule
14 3.769(h).


