The Motion for Preliminary Approval of a Class Action Settlement came before this
 Court, on November 22, 2019, Hon. Thomas S. Clark presiding. The Court having considered
 the papers submitted in support of the application of the Parties, HEREBY ORDERS THE
 FOLLOWING:

1. The Court grants preliminary approval of the Settlement and the Settlement Class
based upon the terms set forth in the Joint Stipulation for Class and PAGA Action Settlement
and Release ("Settlement Agreement"), a true and correct copy of which is attached to the
Declaration of Marcus J. Bradley as Exhibit "1" dated October 28, 2019. All terms used herein
shall have the same meaning as defined in the Settlement. The Settlement appears to be fair,
adequate and reasonable to the Class.

2. The Settlement falls within the range of reasonableness and appears to be
 presumptively valid, subject only to any objections that may be raised at the final fairness
 hearing and final approval by this Court.

3. A final fairness hearing on the question of whether the proposed Settlement,
attorneys' fees and costs to Class Counsel, and the Class Representative's Service Award
should be finally approved as fair, reasonable and adequate as to the members of the Class is
scheduled in Department 17 on the date and time set forth in the implementation schedule in
Paragraph 9 below.

4. This Court approves, as to form and content, the Notice of Pendency of Class Action
Settlement ("Notice"), Hearing Date for Court Approval, and Claims Procedures in
substantially the form attached to the Settlement as Exhibit "1" and also approves the procedure
for Class Members to participate in, opt out of, and object to, the Settlement as Set forth in the
Settlement Agreement and Notice.

5. The Court directs the mailing of the Notice, in accordance with the Settlement, and finds the dates selected for the mailing and distribution of the mailing of the Notice Packet as set forth in the Notice meet the requirements of due process and provide the best notice practicable under the circumstances and shall constitute due and sufficient notice to all persons entitled thereto.

1	6. It is ordered that the Settlement Class is preliminarily certified for settlement purposes	
2	only.	
3	7. The Court preliminarily confirms Plaintiff Daniel Vargas as Class Representative, and	
4	Bradley/Grombacher LLP as Class Counsel.

6	9. The Court sets a Final Approval hearing for $4-24-20$, at 8^{30} in
